Digital Power Packs February Sweepstakes Official Rules (“Rules”)

NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN THIS SWEEPSTAKES. A PURCHASE OR PAYMENT OF ANY KIND WILL NOT INCREASE YOUR CHANCES OF WINNING.

All Disputes Will Be Resolved Solely By Binding Arbitration and Entrants Waive The Ability To Bring Claims In A Class Action Format.

Void where prohibited by law.

BY ENTERING (OR OTHERWISE PARTICIPATING IN) THE SWEEPS (DEFINED BELOW), ENTRANTS AGREE TO THESE RULES, WHICH ARE A BINDING CONTRACT, SO READ THEM CAREFULLY BEFORE ENTERING. WITHOUT LIMITATION, THIS CONTRACT INCLUDES INDEMNITIES TO THE RELEASED PARTY FROM YOU AND A LIMITATION OF YOUR RIGHTS AND REMEDIES.

Eligibility: The Digital Power Packs February Sweepstakes (“Sweeps”) is open only to individuals who are legal permanent residents of and physically located in one (1) of the fifty (50) U.S. (including D.C.), and who are eighteen (18) years of age or older (each, an “**eligible individual**”). Void in U.S. Territories, including Guam, Puerto Rico and where prohibited by law. Employees, officers and directors of PowerPacks, LLC (“**Sponsor**”), teamDigital Promotions, Inc. (“**Administrator**”), Collectors Universe, Inc. (“**Collectors**”), Gamestop Corp., and each of their respective parent companies, affiliates, distributors, subsidiaries, prize providers, advertising/promotion agencies and their immediate family members (i.e., spouses, parents, grandparents, children, grandchildren, and siblings and each of their respective spouses), and/or those living in the same physical address (“**household**”) (i.e., people who share the same residence at least three (3) months a year, whether legally related or not) of any of the foregoing are not eligible to enter or win a prize in this Sweeps. Sponsor, Administrator and each of their respective parent companies, affiliates, distributors, subsidiaries, prize providers and advertising/promotion agencies are each a “**Released Party**” and shall hereinafter collectively be referred to as the “**Released Parties**”.

Promotion Period: Sweeps begins at 12:00:01 AM Pacific Time (“**PT**”) on 2/1/26 and ends at 11:59:59 PM PT on 2/28/26 (“**Promo Period**”).

How to Enter: Eligible individuals have the option to enter the Sweepstakes in one (1) of eleven (11) separate Drawing Categories (defined below) identified below. Eligible individuals may enter into one (1) or more of the drawing categories by submitting a separate entry for each drawing category they wish to enter. To receive an entry, eligible individuals will need to identify in their entry submission one (1) of the eleven (11) drawing categories they would like to be included in (each, a “**Drawing Category**” and collectively, the “**Drawing Categories**”): **(1) Sports/Starter, (2) Sports/Silver, (3) Sports/Gold, (4) Sports/Platinum, (5) Sports/Diamond, (6) Non-Sports/Starter, (7) Non-Sports/Silver, (8) Non-Sports/Gold, (9) Non-Sports/Platinum, (10) Non-Sports/Diamond, or (11) Non-Sports/Lunar.** After an eligible individual has identified their Drawing Category, the eligible individual must write the name of the Drawing Category on their entry in two (2) locations: 1) On the entry itself as described below, and 2) On the outside of the envelope in the lower right-hand corner.

Failure to properly identify the Drawing Category in both places as required above, may result in the entry being null and void.

There is no limit on the number of entries an eligible individual may submit in this Sweepstakes (including for each Drawing Category).

All entries become property of Sponsor and will not be acknowledged or returned. Sponsor reserves the right, in its sole discretion, to void any and all entries of an entrant who Sponsor believes has attempted to tamper with or impair the administration, security, fairness or proper play of this Sweeps. All materials submitted become the physical property of Sponsor and will not be returned. Those who do not follow all of the instructions, provide the required information in their entry, or abide by these Rules or other instructions of Sponsor may be disqualified. The Released Parties may run multiple campaigns, contests, sweepstakes or other promotions simultaneously. Entry into one (1) campaign, contest or sweepstakes do not constitute entry into any other.

Selection of Winners & Odds: Potential winners will be selected in eleven (11) individual random drawings (one (1) drawing for each Drawing Category) conducted by Administrator on or about 3/10/26, from amongst all eligible entries received for each Drawing Category during the Promo Period. All decisions by Administrator and Sponsor as to the selection of winners will be final and binding in all matters relating to this Sweeps. In the event any Drawing Category does not receive any eligible entries, such prize allocated for that Drawing Category will go unawarded. Subject to verification of eligibility and compliance with these Rules, the potential winners will be declared the official winners of the Sweeps. Odds of winning a prize will depend upon the total number of eligible entries received for each applicable Drawing Category during the Promo Period. The potential prize winners will be notified by Administrator via telephone, text message, mail, and/or email (method selected in Administrator’s discretion) in a commercially reasonable time after the drawing. Released Parties are not responsible for false, incorrect, changed, incomplete or illegible contact information. Released

Parties shall have no liability for any winner notification that is lost, intercepted, or not received by a potential winner for any reason.

Prizes: A total of eleven (11) prizes will be awarded in this Sweeps. Federal, state, and local taxes and all other expenses not specified herein are each winner's sole responsibility. The ARV (defined below) of the prizes are based on available information provided to Sponsor and the value of any prize awarded to a winner may be reported for tax purposes as required by law. The Released Parties are not responsible for and winner will not receive the difference, in any, between the actual value of the prizes at the time of award and the stated ARV in these Official Rules or in any Sweepstakes-related correspondence or material. Values of individual prizes are subject to market fluctuation and ARVs disclosed below are based on estimated value data available to Sponsor with respect to the value of the applicable trading card prior to the start of the Promo Period. Prize Details: At winner's selection, prizes may be either shipped to the winner's selected address within the U.S. for free or otherwise deposited securely in winner's PSA Vault (fees apply). CIRCUMSTANCES WILL ANY ENTRANT BE PERMITTED TO OBTAIN ANY AWARD FOR, AND ENTRANT HEREBY KNOWINGLY AND EXPRESSLY WAIVES ALL RIGHTS TO SEEK, INDIRECT, EXEMPLARY, PUNITIVE, INCIDENTAL, CONSEQUENTIAL OR SPECIAL DAMAGES, LOST PROFITS AND/OR ANY OTHER DAMAGES, REGARDLESS OF THE FORM OF THE ACTION OR THE THEORY OF RECOVERY, EVEN IF THE RELEASED PARTY HAS BEEN ADVISED OF THE POSSIBILITY OF THOSE DAMAGES, OTHER THAN ACTUAL OUT OF POCKET EXPENSES NOT TO EXCEED TEN DOLLARS (\$10.00), AND/OR ANY RIGHTS TO HAVE DAMAGES MULTIPLIED OR OTHERWISE INCREASED. SOME JURISDICTIONS DO NOT ALLOW THE LIMITATIONS OR EXCLUSION OF LIABILITY, SO THE ABOVE MAY NOT APPLY TO YOU.

Governing Law; Dispute Resolution Process: All issues and questions concerning the construction, validity, interpretation and enforceability of these Rules, or the rights and obligations of an entrant and the Released Parties in connection with the Sweeps, shall be governed by, and construed in accordance with, the substantive laws of the State of California, USA, without giving effect to any choice of law or conflict of law rules or provisions that would cause the application of any other state's law. Each entrant agrees to final and binding arbitration of all Claims (as defined in the in Section 17 of the [User Agreement](#) (the "Arbitration Agreement")) before the American Arbitration Association pursuant to the written Arbitration Agreement. PLEASE READ THE ARBITRATION AGREEMENT CAREFULLY. IT AFFECTS YOUR RIGHTS AND WILL HAVE A SUBSTANTIAL IMPACT ON HOW CLAIMS BETWEEN ENTRANTS AND THE RELEASED PARTIES WILL BE RESOLVED.

Miscellaneous: No transfer, assignment, cash redemption or substitution of a prize (or portion thereof) will be permitted, except by Sponsor, in its sole discretion, due to prize unavailability or other causes otherwise determined solely by Sponsor, and then for a prize (or applicable portion) of equal or greater value. Parents or legal guardians of any prize winner under the age of majority in their state/jurisdiction of residence (which is eighteen (18) in most states but is nineteen (19) in Alabama and Nebraska and twenty-one (21) in Mississippi) may be required to also sign the Prize Claim Documents in order for the prize winner to be qualified to receive his or her prizes. If any potential prize winner is found to be ineligible, or if he or she has not complied with these Rules, or if the potential prize winner cannot attend or participate in any portion of the prize, or declines a prize for any reason prior to award, such potential winner may be disqualified and an alternate potential winner may be selected. Should a potential winner decide to decline his/her prize for any reason whatsoever or not respond to the prize notification by the applicable response deadline, Sponsor (and, for the avoidance of doubt, the other Released Parties) shall have no further obligation to that potential winner and an alternate

potential winner may be randomly selected from among all remaining Sweeps entries for the prize at issue, if time permits. The Released Parties are not responsible for electronic communications that are undeliverable as a result of any form of active or passive filtering of any kind, or insufficient space in entrant's email account to receive email messages. By participating, entrants acknowledge they have read, understand and agree to be bound by these Rules and agree that Released Parties, and each of their respective designees and assigns and all of their respective officers, directors, employees, shareholders, representatives, agents, and the franchisees of any of them, shall have no liability and entrant will defend, indemnify and hold harmless the Released Parties from and against any liability, loss, injury, or damage of any kind (including attorneys' fees) to any person or entity, including, without limitation, personal injury, death or damage to personal or real property, due in whole or in part, directly or indirectly, by reason of: (i) an entrant's participation/entry into the Sweeps; (ii) any materials he or she may submit in connection herewith; (iii) the acceptance, possession, use or misuse of a prize (or portion thereof) or participation in any activities associated with the Sweeps or any prize (or portion thereof) awarded in connection herewith; (iv) the Released Parties' violation of rights of publicity or privacy, claims of defamation or portrayal in a false light or based on any claim of infringement of intellectual property; and (v) any typographical, human or other error in the printing, offering, selection, operation or announcement of any Sweeps activity and/or prize. The Released Parties are not responsible for the actions of entrants in connection with the Sweeps, including an entrants' attempts to circumvent these Rules or otherwise interfere with the administration, security, fairness, integrity or proper conduct of the Sweeps. Sponsor reserves the right, in its sole discretion, to void any and all entries of an entrant who Sponsor believes has attempted to tamper with or impair the administration, security, fairness, or proper play of this Sweeps and to amend, modify, suspend, and/or terminate this Sweeps (or portion thereof) should virus, bugs, non-authorized human intervention or other causes corrupt or impair the administration, security, fairness or proper play of the Sweeps and, in the case of termination, at its discretion, select potential winners for the drawing at issue via a random drawing from among all eligible, non-suspect entries received for the drawing at issue before the event that required such termination. In the event Sponsor or Administrator is prevented from continuing with the Sweeps by any event beyond its control, including, but not limited to, fire, flood, epidemic, pandemic, earthquake, explosion, labor dispute or strike, act of God or public enemy, communications or equipment failure, utility or service interruptions, riot or civil disturbance, large-scale illness, terrorist threat or activity, war (declared or undeclared), interference with the Sweeps by any party, or any federal, state, or local government law, order, or regulation, order of any court or jurisdiction, or other cause not reasonably within Sponsor's and/or Administrator's control (each, a "**Force Majeure**" event or occurrence), Sponsor shall have the right to amend, modify, suspend or terminate the Sweeps or prize. Sponsor may decide to postpone drawing dates and other deadlines herein or terminate the Sweeps early. In the event the Sweeps is terminated early, Sponsor shall immediately suspend all drawings and prize awards, and Sponsor reserves the right to award any remaining prizes (up to the total ARV as set forth in these Rules) in a manner deemed fair and equitable by Sponsor. Sponsor shall not have any further liability to any entrant in connection with the Sweeps. Sponsor and Administrator additionally reserve the right, in their sole and absolute discretion: (a) to amend, modify, suspend or terminate the Sweeps should a Force Majeure event corrupt or interfere with the administration, integrity, operation, security or proper play of the Sweeps; or (b) to disqualify any entrant found to be, or suspected of: (i) tampering with the entry process or the operation of the Sweeps; (ii) acting in violation of these Rules; or (iii) acting in an un-sportsmanlike manner. CAUTION: Any attempt to undermine the legitimate operation of this Sweeps is a violation of criminal and civil laws and should such an attempt be made, the Sponsor and the applicable Released Parties reserve the right to seek damages (including attorneys' fees) and/or other remedies from any such person(s) responsible for the attempt to the fullest extent permitted by law. The Sweeps and all prizes are provided "as is" and Released Parties make no warranty, guaranty or representation of any kind concerning any prize (or any portion thereof) and disclaim any implied warranty. Some jurisdictions do not allow the disclaimer of implied or other warranties so the above disclaimer may not apply to you to the extent such jurisdictions law is applicable to you and these Rules. Without limiting the generality of the foregoing, entrants agree that the Released Parties: (a) maintain no control over the personnel, equipment or operation of any transportation company, hotel, manufacturer or other person or entity furnishing services, products or accommodations (collectively, "**Suppliers**") as a part of the prizes provided in connection with the Sweeps; and (b) will not be responsible or liable for any injury, damage, loss,
